INTERNSHIP ACKNOWLEDGEMENT OF RISK AND CONSENT FORM

Understand that there are certain risks associated with internship activity(s) described below; an intern however should always base his/ her actions on professional ethics and not on aburst of emotion.

- Some Patients may have **self injurious behavior**. They may **harm themselves or you**. You should be prepared to handle these situations **effectively without using force** against the child/client.
- You may have to **work under stressful** conditions as you have to deal with differently abled individuals, this should **not be reflected** in your behavior inside the work premises, **carry yourself as a true professional**.
- The data privacy is the right of a patient and should be kept in mind, leaking of data, photos, videos, etc. on social media platforms or elsewhere is against the code of ethics and will be dealt accordingly.
- Session report, progress report and other information are valuable prognostic indicators and are to be maintained regularly.
- Damage to any equipment or therapy material will be **penalized** from your **stipend** and/ or **caution deposit**.
- **Referring** the patient to anywhere **without** the knowledge of the concerned **authority** will be dealt with **strict actions**.
- Physical/verbal abuse like beating, screaming, using slangs, high pitch voice (unbearable) is strictly prohibited.
- **Mobile Phones** are not allowed during the working hour. It can be used with permission for special purpose.
- You have to be productive during your posting and utilize the time to learn. Sitting ideal during or after the session will not be tolerated at all.
