(Minutes of Meeting) of Anti-Ragging Committee (ARC)

The Anti-ragging committee meeting was conducted on 21st January 2023 at 2:00 PM in ground floor conference hall.

The following members were present in the meeting;

The following points were discussed; and appropriate actions made and resolutions arrived at.

1. For the session 2023-24, it has been decided that the following items should be included in the students prospectus/ hostel rules and regulations; Directions regarding curbing the menace of ragging, anti-ragging committee, anti-ragging squads constituted by the institution, email helpline, self-declaration by the student, punishment as per UGC and State legislation, etc.
2. The Member Secretary informed the members that Posters as per clause 6(a)-(i) that “the ragging is totally prohibited in the university and anyone found guilty of ragging and/or abetting ragging, whether actively or passively, or being a part of a conspiracy to promote ragging, is liable to be punished in accordance with UGC Regulations as well as under the provisions of any penal law for the time being in force” shall be printed and will be pasted by the office of the Dean Students’ Affairs at all important places in the Campus.
3. The Chairman instructed that the Anti Ragging Squads should regularly visit and keep vigilance in Boys Hostels, Girls Hostels and other vulnerable areas of the college.
4. The Committee members have been advised to have close watch at all outside anti-social elements and it should be ensured that they should not enter the college campus. For this purpose, it is suggested that an intensive patrolling on the Campus should be carried out.
5. The Committee discussed that the Chairperson/Directors shall constitute a Committee under the faculty members by involving Senior students and Freshers to report any act of ragging.
6. The Wardens shall convene the meeting with Deputy & Assistant wardens of all the Hostels and emphasized the necessity of their active involvement in “No Ragging” programme and put them on 24 hours visit to ensure that no incident of ragging takes place on the Campus.
