

3. The Utilisation Certificate (UC)/ Statement of Expenditure (SoE) in duplicate in respect of the fund released herein shall be submitted by the grantee PIAs duly countersigned by the concerned DSSOs to the Additional Secretary to Government, SSEPD Department by 30.06.2024.



They have to maintain report card for each beneficiary and photo album of their activity both in hard and soft copies. They have to submit copies of the album and report their milestone achievements during the year to SSEPD Department.

The fund released herein shall be subject to the following conditions:



2. Participation of experts working in this Department shall be allowed to benefit out of the seminar.


