2. The State Govt. shall not give any grant for building etc. at any time. The building intended for educational occupancy will not be used for any hazardous occupancy.
3. The State Govt. shall not take over the institution at the requested of the institution.
4. The institution shall seek approval and affiliation from the concerned University / State Board and send the copy of the approval / affiliation to the Registrar / Chairman for record.
5. All the conditions of affiliation prescribed by the affiliating University or Board will have to be met by the Institution.
6. The institution authorities will recruit the staff as per Government / University guidelines and pay the salary to the staff in the pay scale prescribed by the Govt. from time to time.
7. Tuition fee and other charges will be as per the norms prescribed by Government / affiliating University / Board.
8. The Government can impose any other condition(s) at any time, which shall be binding on the Institute.

9. In case, the institute is not able to admit candidates for the academic session for which NOC was issued, the institutions will be given scope for revalidation for subsequent two years.
10. Any contravention of the above stated conditions shall result in withdrawal of the "No Objection Certificate" and action deemed fit against the defaulting society / institution.
11. The NOC is subject to the outcome of W.P. © No. 9440/2016, W.P © No. 9442/2016, W.P. © No. 9443/2016 and W.P. © No. 9448/2016.
12. The institution cannot change their address or location without permission from Government.



11. Any contravention of the above stated conditions shall result in withdrawal of the "No Objection Certificate" and action deemed fit against the defaulting society/ institution.
12. The institutions cannot change their address or location without permission from Government.

Further, necessary instruction shall be issued to the aforesaid Private institutions imparting physiotherapy courses to submit a declaration in addition to the affidavit to the fact that, they have complied all the requisite provisions of the guidelines framed by the Government scrupulously and if the same found to be untrue appropriate action can be taken under the provisions against them.

Similarly, when physical inspection of the Institutes is taken up the contents of the Affidavit be scrutinized / examined by the Inspecting team to ascertain the veracity of the Affidavit.


1. That this recognition is only for the purpose of obtaining affiliation from Utkal University and shall not entitle the organization /institution for any other benefit.
2. That the institution will not claim grant-in-aid from the State Government at any point of time.
3. It should be ensured that the institution does not admit more students than the intake capacity of authorized 64 seats and charge fee in excess of the limit fixed by Government.
4. This recognition of State Government is valid until further orders.
5. The Institution should abide by all the conditions provided under Persons with Disabilities (Equal Opportunities, Protection of Rights and full participation) Act 1995 and follow the reservation policy of State Government.
6. Recognition shall be withdrawn at any time on default of any of the conditions on which this recognition is accorded.


