RESOLUTION

The 20th November 2006

Subject: Declaration of Institute of Health Sciences, Bhubaneswar as a referral hospital for treatment of Government employees.

The Government of Orissa in Women & Child Development Department has made an effort of identifying institutions for clinical intervention and rehabilitation services in communication disorder. There are some organizations who have integrated the process in their existing institutions/hospitals. Now at Bhubaneswar it is The Institute of Health Sciences, who have developed some exclusive facilities for treatment in communication disorder.

The institution has been registered under the provisions of Persons with Disabilities (Equal Opportunities, Protection of Rights And Full Participation) Act, 1995 and has been recommended by Rehabilitation Council of India (RCI) to act as a referral center for Communication Disorder i.e. Speech and Hearing disorders for all age groups, including CP, MR, Autism, ADHD, Neurogenic speech and language disorders etc. to help the disabled persons in Orissa. They have developed modern facilities for exclusive treatment in communication disorders to fill a gap in existing health care facilities for the people in general and persons with disabilities in particular.

Keeping in view the available facilities at the Institute, the State Government after careful consideration have been pleased to declare Institute of Health Sciences, Bhubaneswar as referral centre to help in treatment of all types of Communication Disorders i.e. Hearing, Language and Speech disorders.

The Resolution shall come into force from the date of its issue.

Sub: Release of funds in favour of Non-Governmental Organisations (NGOs) for providing therapeutic and rehabilitative services to Persons with Intellectual Disabilities out of Budget estimate for the year 2015-16 under State Plan.

Sir,

A sum of Rs.1,54,50,000/- (Rupees one crore fifty four lakh fifty thousand) is hereby released against the approved amount of Rs. 3,09,00,000/- (Rupees three crore and nine lakh) in favour of the 19 (nineteen) number of NGOs as listed against each in the Annexure-I for providing therapeutic and rehabilitative services to Persons with Intellectual Disabilities out of Budget estimate for the year 2015-16 under State Plan.


2. The amount released herein shall be subject to the following conditions:-

- i. The amount released herein shall not be utilised for the purpose other than for which it is released.
- ii. The released amount shall be fully utilised by the end of current financial year 2016-17.
- iii. Detailed account of expenditure shall be maintained for the amount released herein. The accounts together with all relevant documents/papers shall be opened for audit by the Auditors of this Department as well as for the test check by the A.G., Odisha, Bhubaneswar.
- iv. The Statement of Expenditure (SOE)/ Utilisation Certificate (UC) in duplicate in respect of the amount released herein shall be submitted by the grantee to the Joint Secretary to Govt., SSEPD Department who will transmit the same to the FA-cum-Addl. Secretary to Govt., SSEPD Department.
- v. The fund will be released in favour of the NGOs through credit system in their respective Bank Accounts as submitted by them and mentioned against each in the Annexure-I.
- vi. Rest of the approved amount will be released in favour of the respective NGOs on submission of the SOE/UC against release of first instalment of fund.

3. The release of fund shall be strictly abided by the terms & conditions laid down in Office Memorandum No-1214 dated 20.02.2016 of Department of SSEPD.
4. Government reserves the right to withhold release of fund either in full or in part against any of the NGOs without assigning any reason thereof.
5. The NGOs shall have to maintain photo album of their activity both in hard and soft copies and submit copies of the album to the Department of SSEPD.
6. Government may ask the NGOs to undergo training programmes and exposure visits relating to this initiative as and when decided to do so on the terms & conditions decided from time to time.
