Madam,

I am directed to request you to transfer fund for ₹ 2,52,39,816/- (Rupees Two Crore Fifty-two lakh Thirty-nine Thousand Eight Hundred Sixteen only) in favour of 21 PIAs providing therapeutic and rehabilitation services to persons with intellectual disabilities under the programme **Rehabilitation of Physically and Mentally Challenged Socially Disadvantaged Persons** towards Grant-in-Aid during the year 2021-22 as indicated in Annexure- 1.

The fund released herein shall be subject to the following conditions:

1. The fund released herein shall not be utilised for any other purpose and the expenditure shall be incurred strictly in accordance with the terms and conditions laid down in the Guidelines issued in SSEPD Department Letter no. 2275 dated 04.03.2021. The fund released herein need to be utilized, component wise and shall be fully utilised by end of the current financial year 2021-22.
2. Detailed account of expenditure shall be maintained for the fund released herein. The account together with all relevant documents/ papers shall be opened to Govt. audit as well as audit by AG (G&SSA), Odisha.
3. The utilisation Certificate (UC)/ Statement of Expenditure (SoE) in duplicate in respect of the fund released herein shall be submitted by the grantee PIAs duly countersigned by the concerned DSSOs to the Joint Secretary to Government, SSEPD Department by 30.06.2022.
4. The fund will be released in favour of the PIAs by credit system in their respective bank accounts as mapped under PFMS. The sanctioned fund shall be released in favour of the PIAs after due verification of pending UCs and on the basis of 'report of inspection' on the performance of PIAs taking into consideration the number of beneficiaries, satisfactory performance of the centres recorded for the year 2021-22 in the prescribed format.

6. The PIAs shall have to maintain report card for each beneficiary and photo album of their activity both in hard and soft copies. They have to submit copies of the album and report their milestone achievements during the year to SSEPD Department.




