RESOLUTION

Sub: Enhancement of the rates of maintenance grant to both residential and non-residential (day scholars) Children of Special Schools and introduction of non-recurring and one time grant to Special Schools.

In exercise of the powers conferred by clause-12-1(B) of the Grant-in-Aid guidelines' 2013, the state Government have been pleased to enhance the existing rate of maintenance grant from Rs. 1,200/- to Rs. 1,760/- per head per month for residential students and from Rs.250/- to Rs.370/- per head per month for non-residential students of the Special Schools receiving grant from the state Government with effect from 01.04.2020. The component-wise breakup of the enhanced maintenance grant is given below:
