

Sub - Recognition for Bachelor in Audiologist and Speech Language Pathology degree under Institute of Health sciences

Sir,

I am directed to invite a reference to your letter No.5415 dt.30/12/2014 and Department letter No.13530 dt.13/6/2002 and letter No.18619 dt.13/11/2014 on the subject noted above and to say that Government have been pleased to accord permanent recognition to IHS under Utkal University for running BASLP (Bachelor in Audiologist and Speech Language Pathology) courses with 64 seats until revoked by Government and with the following conditions:

1. That this recognition is only for the purpose of obtaining affiliation from Utkal University and shall not entitle the organization /institution for any other benefit.
2. That the institution will not claim grant-in-aid from the State Government at any point of time.
3. It should be ensured that the institution does not admit more students than the intake capacity of authorized 64 seats and charge fee in excess of the limit fixed by Government.
4. This recognition of State Government is valid until further orders.
5. The Institution should abide by all the conditions provided under Persons with Disabilities (Equal Opportunities, Protection of Rights and full participation) Act 1995 and follow the reservation policy of State Government.
6. Recognition shall be withdrawn at any time on default of any of the conditions on which this recognition is accorded.




